Kigali International Arbitration Centre (KIAC) though the Chartered Institute of Arbitrators (CIArb) will conduct an Accelerated Membership Program (AMP) leading to Member of CIArb (MCIArb). The course will take place from 1st- 2nd April 2019 at KIAC Office. According to CIArb-UK regulations, each session is limited to 25 participants only. We shall apply the principle of first come-first serve. The deadline for registration is 28th February 2019.

About the Accelerated Membership Program of the Chartered Institute of Arbitrators

The Course consists of intensive reading. The participants take part in different oral assessment workshops (Day one) and a 3 hours written examination with questions on a defined syllabus (day two).

PLEASE NOTE, this is not a teaching course but an evaluation and assessment of a participants' knowledge of basic law, dispute resolution, and ability to deal with given situations (For more details about AMP please visit CIArb website (www.ciarb.org). Results are dispatched to candidates normally eight to twelve weeks from the date of assessment and examination.
